### CIRCLE OF FAITH RIPPLES

Grace to you and peace from God our Father the Lord Jesus Christ.

As I settle into the parish, I am noticing what a great partnership that is beginning to form between the three congregations. It is wonderful to see people working together all for the sake of the gospel. We will continue working on building up our partnership with each other over the next months and years. One thing that I am realizing that the pastoral staff could use some help on from you is information. With the new HIPAA laws, pastors are usually the last people to hear if someone is hospitalized or goes into a long-term care facility. We need your help.

When the government passed the new HIPAA laws, it made it difficult for pastors to remain informed about hospitalizations. HIPAA stands for Health Insurance Portability and Accountability Act. It requires health care providers to institute new policies and practices to protect the health information of patients and residents. Prior to the HIPAA laws, pastors were privileged with a lot of information. We could go to the hospital and see a list of all the patients to see if any were our members. Plus, in some small settings, hospitals or care facilities would actually call your pastor upon your arrival. This is no longer the case. Pastors are no longer informed when someone is admitted to a hospital or care facility. We now rely on you. If you are admitted to a hospital or other care facility and would like a visit from one of your pastors please call us or have a family member or friend call us.

Part of our Christian calling is to visit and care for the sick. The Letter of James says, "Are any among you sick? They should call for the elders of the church and have them pray over them, anointing them with oil in the name of the Lord. The prayer of faith will save the sick, and the Lord will raise them up; and anyone who has committed sins will be forgiven. Therefore confess your sins to one another, and pray for one another, so that you may be healed. The prayer of the righteous is powerful and effective." (James 5:14-16)

We all are called to visit and care for the sick, but we cannot do that unless we know who has been admitted to a health care facility. So please help us pray for and visit you. Word of mouth is still the best way to pass on information. If you hear of someone being admitted to a health care facility please call the church office or one of the pastors.

Circle of Faith Parish Council Meeting Minutes July 1, 2013

Meeting was called to order at Legends in Ceylon at 6:50 pm by President Steve Williamson. Members present: Merle Burmeister, Marilyn Cheever, Jody Franck, Jon Helvig, Joel Rabbe, Kirsten Rabbe, Jon Saxen. Members Absent: Liz Stahl. Congregational Presidents present: Deanne Gaalswyk, Waverly; Jody Franck, St. Peter. Steve welcomed Pr. Anthony to Circle of Faith.

Pr. Anthony gave devotions, based on Psalm 119. "Your word is a lamp to my feet, and a light to my path."

Kirsten Rabbe presented the Secretary's Reports for the June Parish Council and June Executive Board meetings.. Motion by Jody Franck, seconded by Jon Helvig. to approve both Secretary's Reports as presented. Motion passed.

Joel Rabbe presented the Treasurer's Reports for June. Motion by Jon Helvig. seconded by Merle Burmeister to approve the Treasurer's Report as presented. Motion passed.

#### Pastor Anthony Christoffel's Report

The voicemail system will be set up this week. He asked about the publication dates of the most recent picture directories, as a point of reference. Pr. Anthony will hold cottage meetings in homes of congregation members this fall, as listening and idea sessions about Circle of Faith Parish.

Pr. Anthony asked who is responsible for scheduling Pastoral Care visits, the pastors or the parish administrator. The Council explained that in the Parish Administrator's job description, paragraph 2 under Specific Responsibilities states "Coordinate calendar, appointments and meetings." and sub-paragraph g. specifies, "Set up appointments for Pastor(s) as requested and needed." With that clarified, Pr. Anthony will begin working with Lisa to help her learn that task, prior to the arrival of our Associate Pastor.

Question from the Council: How are the names of those who will be visited being generated? Pr. Anthony said by pastoral staff, as they see needs come up, with lots of help from the congregational members and leadership, who need to let the office or pastors know when someone needs pastoral care.

Discussion was held on how to schedule pastors for worship, so that people who work every other weekend get the chance to hear both pastors.

Clarification of church holidays: The church office will be open M-F, 9 am to 1 pm, except on major holidays of New Years, Memorial Day, 4<sup>th</sup> of July, Labor Day, Thanksgiving or Christmas. The office will be staffed on days before or after holidays.

#### Ministerial Associate's Report

When Carl calls to schedule a visit with parishioners, he has found that most have not been visited by a pastor unless they have been ill or have lost a loved one. Most members have been receptive to a visit when contacted. Carl emphasized that the pastoral staff is trying to visit every member in the parish in their homes, over a period of time.

Carl emphasized the need for members and/or their families to communicate with the parish office when someone is hospitalized. Sometimes people just assume that the pastors/office know, but often this is not true. We will ask congregational councils to emphasize this with their members.

Finally, Carl once again asked for suggested names of people to visit during his time with us. While he will make every effort to visit inactive members, and prospective members, he would also like to meet with anyone in the parish. President Steve asked Congregational Presidents and Councils to help give him the names he needs

The Parish Council asked if Carl has encountered any other obstacles. (No.) When asked for a "barometer reading" of members' impressions of Circle of Faith thus far, Carl reported "Guardedly optimistic," and "Looking forward to a bright future together."

#### **OLD BUSINESS**

#### Office renovation update

Merle Burmeister reported that Associate Pastor's office now has a window and an Air Conditioner/Heating unit as well. The Pastor's offices and Parish Administrator's office all have a fresh coat of paint. Carpet has been donated for the Associate's office and stairs. Installation of carpet will cost \$600.00. Recarpeting the Parish Administrator's office will not happen at this time, as the existing carpet is still in good condition, and there is not money left in the budget to cover the extra cost. A shelving unit and floor lamp have been purchased for the Associate's office, and are awaiting carpet installation before they are put in place. Circle of Faith will cover renovation costs for the office.

#### **Fall Education Update**

Pres. Steve Williamson talked about the possibility of creating a Wednesday joint education night for Circle of Faith, that might eventually encompass confirmation, adult bible study or forums, and maybe even Sunday School, eventually. This would make it easier for pastors to be involved in many aspects of parish education, could be more fun for those participating, especially young people, could increase interaction between pastors and the young people of our congregations, might make it easier to recruit teachers, among other long term benefits. Discussion was held on the pros and cons of the idea, and potential points of conflict were identified.

The Council recommended that Pr. Anthony begin working with Congregational Presidents to organize joint confirmation for the coming year. Long term, the Congregational Councils will be consulted for their ideas and input on the potential of an expanded Wednesday afternoon/evening program. Pres. Steve will work with the congregations to bring together the stakeholders who would be involved (and affected) to brainstorm possibilities for the future.

Discussion was held on past confirmation and Sunday School schedules for each congregation.

Discussion was held on the necessity to meet young families where their needs are, so they can be included in our congregational lives to the fullest extent possible.

#### Annual Meeting for the Parish

In order to be accessible and accountable to all Circle of Faith members, the Parish will hold an annual meeting prior to the congregational annual meetings, after the budget for the following year has been negotiated and proposed. Members of all congregations would be encouraged to attend. The actual date will be set in the coming months.

#### **NEW BUSINESS**

#### **Associate Pastor Contract**

Motion by Kirsten Rabbe, seconded by Joe Rabbe, to offer a contract for the part-time position of Associate Pastor, effective July 28 – December 31, 2013, to Pr. Eric Midthun. Discussion: as this is a contracted position, rather than a call, it does not require synod approval or a congregational vote. The option to renegotiate the contract or change to a call for Pr. Eric beginning in 2014 is written into the contract. Motion passed. Motion by Jody Franck, seconded by Jon Helvig to approve the contract for Pr. Midthun as presented by the Finance Committee. Motion passed.

#### Fall Worship Schedule

Congregational Presidents have been asked to consult their councils on our worship schedule from September 1, 2013 – May 31, 2014. At the request of Pr. Anthony, there will be 2 service times offered, the first beginning at either 8:15 or 8:30 am, the second beginning at 10:15 or 10:30 am. Two churches will have worship at one time, one church at the other. The Parish Council asked for guidance from the Congregations by their August meeting, so a schedule can be published in time for the September Ripples of Faith. Discussion was held on ways to help facilitate the pastors' transitions at the end of worship service. Discussion was also held on how much each of our congregations has already learned from our partners in Circle of Faith.

#### 2013 Special Services Schedule

Discussion was held on past practices of the three congregations for Thanksgiving and Christmas worship services. Initial suggestions included a joint Thanksgiving service, to be held the Wednesday evening prior to Thanksgiving each year, rotating between the churches from year to year. As each congregation's Christmas Eve service has a strong basis in tradition, we will work to keep those schedules in place as much as possible. Christmas Day there will be no worship service, except in years when Christmas Day falls on a Sunday.

A final schedule will be adopted in August, after consultation with each congregation.

#### **Parish Council Meeting Date**

Motion by Jody Franck, seconded by Joe Rabbe, to move Parish Council meetings to the second Tuesday of every month, at 6:00 pm. Meetings in the months of January, April, August, and November will be Joint Council meeting dates. Meeting in a common location these four months, the Parish Council will meet from 6-7 pm, and all Congregational Councils will meet from 7-8 pm. Congregational Councils will be encouraged to attend the Parish Council meetings on those evenings. This will allow for joint decision-making, better long term planning, and more transparency. Motion passed.

Our next Parish Council meeting will be August 13, 2013, 6-7 pm, with all three congregational councils meeting from 7-8 pm. The August meeting will be held at Trinity in Welcome.

Kirsten shared correspondence from Pr. Giese, thanking the Parish and Parish Council for their generous gift. He will use it to purchase a new Lenten stole, as his old one is completely worn out.

Motion by Jody Franck, seconded by Merle Burmeister, to adjourn the meeting at 8:55 pm. Motion passed.




#### **Fall Worship Schedule**
