Pastor Anthony shared a devotion

The conversation was continued with First Lutheran in Trimont. They are excited about the potential partnership. Pastors have spoken with synod since votes are challenging with Covid. They are suggesting an interim agreement, have us work on details and then hopefully be able to vote this spring or summer. This allows shared pastoral care. The suggested contract was discussed. Article X was removed as there will be no call process during the interim period. Added to Article XI was the potential for extension or early suspension of the agreement. Nancy Nordstrom made a motion to accept the amended Interim Parish Agreement, seconded by John Borchardt. Approved.

Marilyn welcomed Pastor Stephanie.

An addition was made to the agenda under old business to revisit additional compensation for Pastor Anthony for the months he was the sole pastor. The by-law discussion was removed for a later date.

A motion was made by Jody Franck to accept the secretary's report as printed, seconded by Nancy Nordstrom. Approved.

A motion was made by John Borchardt to accept the treasurer's report as printed, seconded by Jody Franck. Approved. Also thanked Jon Saxen for his work on paperwork for some covid relief funds.

Pastor Anthony's report: the covid grants are treated as a reimbursement, receipts were submitted, all three churches received funds. St. Peter received \$4432 from the county, Waverly received \$9929 from the county, and Trinity received \$7418 from the county and \$4000 from the city of Welcome. All checks have been received.

We have more masks.

Christmas Eve sign-ups are going well.

Pastor Stephanie's report: Glad to be here, looking forward to First joining and being church together.

Congregation reports: Waverly is working on budget and council positions.

Old Business:

Compensation for 3 months – it was extra hours, about 10-15 per week. If we were looking at full overtime pay it would be \$400-\$440 per week. \$5000 was suggested to compensate for extra hours. Nancy Nordstrom made a motion to pay this amount, seconded by Jody Franck. Approved with one opposing vote.

New Business:

Old Circle of Faith computers, potential uses are Waverly needs a laptop for the treasurer, Trinity could use Lisa's old one for livestreaming, if St. Peter needed one Pastor Eric's laptop is available. They are going to see if their treasurer would like to use it.

Pastor's continuing education – Pastor Stephanie is going to be attending a training to be able to teach Safe Talk and 4 hour suicide prevention training. The training for this is a 2 day course. Pastor Anthony would like to attend as well. The class is \$1200, he has \$750 unused from 2020, he would like to carry this over and use this along with 2021's to pay for it. MaryAnn Frerichs made a motion to carry over the 2020 funds for continuing education, seconded by John Borchardt. Approved.

Nancy Nordstrom made a motion to approve the housing allowances as printed for Pastor Anthony and Pastor Stephanie, seconded by John Borchardt. Approved. Cont. next page ... Group cast quote: It allows us to do what we currently do with Honeywell, it also sends to social media automatically. It comes out cheaper than Honeywell – no set up fees and they are committing to the price for 5 years. Marilyn would like to see someone from each church trained to use it. Jody Franck made a motion to switch to group cast messaging for \$734 a year with a five year commitment, seconded by Tim Peterson, approved.

MaryAnn Frerichs made a motion to accept the 2021 budget as printed, seconded by Nancy Nordstrom. Approved.

Discussion on virtual church. We are going to attempt to stay in person through Christmas. In person worship will be suspended December 25 to February 2021. Numbers will be looked at in January 2021 to see if we can go back to in person. The department of health is suggesting no in person right now. It was asked if one service might be possible. Nancy Nordstrom made a motion to go virtual December 25 and evaluate in late January if it is safe to return to in person, seconded by Jody Franck. Approved.




